2. No possession or discharge of fire arms.
3. Facilities to be vacated in the condition and location they were provided, all trash removed. Requestor agrees to pay any fees incurred to clean or repair the facilities attributable to the use by requestor.
4. Adequate supervision should be provided by the Requestor to ensure proper and safe use of the facilities.
5. Requestor agrees to abide by the non-discrimination clauses as contained in the Montana Human Rights Act and the Government Code of Fair Practice.
6. Violation of any condition is grounds for termination of this agreement and use of the Park facilities.
7. While the Park provides one vault toilet, Porta potties should be supplied by the Requestor when crowds are expected.
8. The Park also provides one trash receptacle. Requestor must provide additional bins to handle all trash from the event.
9. Requestor has read and agrees to the Lone Rock Park Policy.

### Field Use Fees

- One Time Use, Per field, Per Day \$25
- Seasonal Use, Per League \$150
- Seasonal Use, Out of Area (No LR residents) \$25 per day
- Seasonal Use, Out of Area, more than 10 days \$250
